

Proposed changes to Keystone Region, Chapter By-Laws

Changes to the Keystone Region Chapter SDC By-laws changes are being proposed in accordance with present Keystone bylaws. These changes include;

1. Renewal dues are paid no later than December 31st of each year instead of
January 31.
2. General Business meetings shall be held twice a year instead of quarterly.
3. The Executive Committee shall meet quarterly instead of as often as deemed
necessary.
4. Nominating one (1) person for office instead of two (2) each year.
5. Ballots returned before November General Business Meeting
6. Ballots counted at November General Business Meeting
7. New officers installed at December installation banquet and continue
for one year
to the following December.
8. Provisions for dissolution of Keystone Region Chapter, SDC

The executive committee is proposing these amendments to the membership in this issue of Keynotes. A vote to approve each of these individual amendments will be conducted at the general business meeting scheduled to start at 1PM November 18, 2017 located at Hoss's Restaurant in Hummelstown. In lieu of attending this business meeting to vote, Members may mail in their ballot (included in this newsletter). Ballots must be received at the designated address before October 30, 2017. Ballots received before this date will be included in the ballot count at the November 18 Business meeting.

The exact change for each of the amendments follows;

ARTICLE II

Membership and Dues

1. Upon payment of dues, any Person meeting these qualifications shall be a member of Keystone Region Chapter, Inc. and shall remain as such providing renewal dues are paid no later than January 31st December 31st of each year.

ARTICLE III

MEETINGS

1. GENERAL BUSINESS MEETINGS

General Business Meetings shall be held ~~quarterly~~ twice (2) per year February and November ~~quarterly (4 times per year)~~ upon no less than thirty (30) days advance notice published in the "Keystone Keynotes" for the purpose of conducting current and future Chapter business.

2. EXECUTIVE MEETINGS

Executive meetings ~~may~~ shall be held by the Executive Committee quarterly or as often as they deem necessary at times and places determined by them for the purpose of conducting business not requiring membership action or approval.

ARTICLE V

ELECTIONS

(B) The Nominating committee shall nominate at least ~~two (2)~~ one (1) persons ~~s~~ per elective office for publication in the September-October "Keystone Keynotes" issue. [Amended June 5, 1968]

(E) Ballots shall be returned on or before the November General Business Meeting, as announced in the "Keystone Keynotes".

(F) Ballots received, shall be counted by the Nominating Committee at the November General Business Meeting and new officers announced.

(G) The newly elected officers shall be installed at the December installation banquet and continue their term for one year to the following December. ~~election meeting.~~

ARTICLE X

DISSOLUTION

In the event that the Keystone Region Chapter, Inc. ceases to function, or in the event that the members decide to terminate it, the Officers of the Keystone Region Chapter, Inc. shall, after paying or making provision for

paying all of the Keystone Region Chapter's liabilities, distribute all of the remaining assets of the Keystone Region Chapter, Inc. to another organization that is devoted to the Old Car Hobby and is a subject of section 501(c)7 or 501(c)3 of the Internal Revenue Code.
